### QUALIFICATION FOR ADMISSION

1. Master's degree in Business Administration, Information Technology, Information System and other related field from the institutions accredited by the Ministry of Education, Thailand.
2. GPA of at least 3.25

### APPLICATION REQUIREMENTS

1. A completed application form
2. Official transcript of the previous university attended both of Bachelor and Master (1 copy)
3. Bachelor and Master degree (1 copy)
4. Citizen identification card and house registration (1 copy) - for Thai applicants
5. Passport (1 copy) - for Non-Thai applicants
6. One (1x1.5 inches) photograph (formal attire, not in graduation gown)
7. Two recommendation letters from former instructors or employers at the time of the application
8. Present a brief research proposal in the field of Business Administration, Information Technology, Information System and other related field.

Note : All documents must be endorsed with signature and submitted in person within the last day of application period, otherwise the application will not be considered.

Applicants who are graduates from overseas universities will be required to provide at the time of applying and not later, certified, attested, or notarized by competent notaries, all academic documents with the seal or stamp by the Ministry of Foreign Affairs, Ministry of Education or related department.

### ENTRANCE EXAMINATION

- AU English Proficiency Test
- Interview Entrance Examination

### EXEMPTION

The AU English Proficiency Test can be exempted depending on which of the following conditions that you satisfy.

- a TOEFL score of (iBT) 90 or an IELTS (Academic) score of at least 6.5 (Validation: Two years)
- a Bachelor's degree from native English speaking countries (USA, Canada, UK, New Zealand and Australia)

### GRADUATE REQUIREMENTS

1. Complete the total number of credits of the program
2. Achieve a cumulative grade point average of at least 3.00
3. Have the dissertation / part of the dissertation published or obtained an acceptance of its publication in a national or international journal in accordance with OHEC's Regulations
4. Maintain proper conduct worthy of being a doctoral degree holder
5. Settle all financial obligations to the University
6. Fulfill the requirement of an out-of country fieldtrip
